In continuation of DO letter of even number dated April 29, 2015 from Secretary, Ministry of Panchayati Raj regarding celebrating 'Digital India Week' (DIW) under the Digital India Programme to inform, educate and engage citizens in the ongoing initiatives of the Government in the area of e-Governance, I would like to inform that Digital India Week will be launched by the Hon'ble Prime Minister on July 01, 2015 at 4 pm and the DIW will be celebrated from July 01, 2015 to July 07, 2015. As has been communicated earlier, during the DIW, the Gram Panchayats (GPs) may be advised and encouraged to actively engage in the following activities:

(i) Organise special Gram Sabha meetings on Digital India on 2nd July, 2015;

- (ii) To publish the updated list of e-services being provided through GPs and other touch-points like Common Service Centres, Block Development Officer, Tehsil/Taluks, etc., in all GPs to create awareness at local level;
- (iii) To update their websites and other information portals (*AreaProfiler*, etc.) during the DIW; and
- (iv) Promotion of the mobile App (m-Asset) specially developed for DIW by MoPR to capture the coordinates (latitude, longitude) of the immovable assets of Panchayats on a GIS platform to map all the assets of Panchayats. The App can also be accessed directly by citizens after self-registration. The mobile app can be downloaded from home page of <u>http://assetdirectory.gov.in/</u> or <u>http://panchayat.gov.in</u>.
- (v) An indicative schedule of activities at Panchayat level during DIW may be seen at Annex-A. In addition to this, the States may also promote activities as per their preparedness.

2 The GPs may be advised to arrange TV and radio to watch and listen Hon'ble Prime Minister's address collectively by the elected representatives, Panchayat officials and members of the Gram Sabha on the launch of DIW. The Nodal Officers designated for the DIW may be asked to use the mobile application of NeGD (<u>http://diweek.cloudapp.net;</u> username: no_mopr; password: test@123) to capture and monitor the progress of DIW on regular basis.

3. The DeitY has approved a budget of Rs. 93 lakhs for incentivization of Panchayats and citizens engaged in various activities during the DIW. It is planned to award Rs. 50,000, Rs. 30,000 and Rs.20,000/-, respectively to the three best performing Panchayats in every State, besides awarding Rs. 5,000/- to the most active Panchayat in every District and award Rs. 500/- each to 20 citizens in each State who have taken active part in the activities. As already informed, the State Governments may develop their own criteria for selection of best performing Panchayats at the State level and for each district and also the citizens who actively participate in the activities for giving them awards. The funds budgeted for Panchayats and citizens are being placed at the disposal of the respective State/UT IT Secretaries by the Department of Electronics and Information Technology (DeitY). State Panchayati Raj Departments are advised to contact the State IT Department to access these funds. A copy of the letter from DeitY is enclosed at Annex-B. The MoPR will provide necessary support needed in this endeavor. Furthermore, the State and District NIC officials may also be contacted for any technical support.

4 Hence I would request you to issue necessary instructions immediately to GPs in your State/UT, to make the DIW a success.

2. The budgeted funds for all the activities for Ministry of Panchayati Raj in States/UTs will be sent to the respective State/UT IT Secretaries. You are hereby requested to kindly direct the State/UT Nodal Officers of Ministry of Panchayati Raj to co-ordinate with the State/UT IT Secretaries for disbursement of funds and distribution of awards to the winner Panchayats as well as citizens. The funds would be released as and when the report is received through the mobile app/ portal created for this purpose.

4. Further, with reference to the Activity Plan received from Ministry of Panchayati Raj, some suggestions have been made as below:

- i. The outreach activities of DIW should be increased and be equally spread on all the days, such as: a.) Gram Panchayats broadcast Hon'ble Prime Minister's address to the citizens on the launch of Digital India on 1st July 2015 at 4 PM onwards; b.) Display of all the e-services (through posters) under Digital India that can be availed at various touch-points like: CSCs, GPs, BDO Office, Tehsils/Taluks etc.
- ii. It is proposed to involve more citizens and Panchayats in the incentive plan and the number of citizens to be awarded for the work can be increased to 20 instead of 10. For Panchayat competitions it is suggested that there be one best performing Panchayat from each district in addition to the three best performing Panchayats across the state.
- iii. Nodal Officers and Panchayats can use the Mobile Application of NeGD to capture and monitor the progress of Digital India Week on regular basis. The App can be downloaded by logging in at the following link: <u>http://diweek.cloudapp.net</u>; Username: <u>no_mopr</u>; password: <u>test@123.</u>
- iv. Also it is requested to use branding "An initiative under Digital India Week" on all the services or mobile applications being launched by Ministry of Panchayati Raj during the week.
